Italian Vacation Contest Official Rules

Eligibility: Italian Vacation Contest (the "Promotion") is open only to legal residents of the Tennessee, Kentucky, Georgia and Florida who are at least eighteen (18) years old at the time of entry. Void where prohibited. The Promotion is subject to all applicable federal, state and local laws and regulations. Participation in the Promotion constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Promotion. Every customer who purchases a half or whole Made to Order Italian Sub from a Twice Daily or White Bison retail location will be automatically entered if the customer presents a valid Twice Daily / White Bison Rewards identification at time of purchase. Use of any automated system to participate is prohibited and will result in disqualification. The potential winner will be required to show valid United States ID.

The winning entrant will be notified by email and must supply age verification and will receive the Prize within approximately two (2) weeks after the verification.

Sponsor reserves the right in its sole discretion to disqualify any individual it finds to have tampered with the entry process or the operation of the Promotion or to have acted in violation of these Official Rules, in violation of applicable law, or in an unfair or disruptive manner. Any attempt by any person to damage any web site or property used for or to undermine the legitimate operation of the Promotion is a violation of criminal and civil law and will result in disqualification. Should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of such right.
